All the applicants has to submit their application on <https://sndtwuonline.org.in> link up to **September 30th 2024 without fail**. After submission of the application through the online process, it must be submitted in one (1) hard copy to the Affiliation Section, SNDT Women's University, Mumbai-400020 on or before **5th October 2024** up to 5.00 p.m. except 2nd and 4th Saturday, Sunday and Public Holidays.


